Attendance

Excellent attendance promotes academic achievement. Research shows that missing just 10% or two days per month has a negative impact on academics. Please make an effort to get your child here on time consistently, and to schedule appointments outside of the school day.

The school hours are listed above and after 8:10, students are considered tardy. New York State Education Law requires a written excuse, signed by the parent or guardian stating the reason for the child's absence or tardiness. *Please send a written excuse in the day your child returns to school after an absence.*

Absences will be categorized as excused or unexcused. Excused absences include: illness, death in the family, unsafe roads, religious observance, and court appearances. Unexcused absences include: family vacation, babysitting, oversleeping, etc. Teachers will make an effort to provide make-up work upon a student's return to school, *after* an unexcused absence.

For Ann Elementary School Staff will address attendance concerns through strategies such as: phone calls, conferences, letters, home visits, and referrals to outside agencies when necessary. Behavior and Code of Conduct

We ask our elementary students to be safe, be respectful, and be kind to others. We also encourage students to be leaders. The full version of the Fort Ann Central School Code of Conduct can be found on the website.

If you have a concern that your child is experiencing bullying or conflict with his peers, please contact the classroom teacher, school counselor, and/or principal. We will address all incidents promptly, as it is our goal to have a positive learning environment. Please call 518-639-5594 for assistance with your concerns.

Birthday Celebrations

Families often enjoy sending in a special treat on birthdays. Please contact your child's classroom teacher about this. Delivery of items such as flowers/balloons to classrooms are not permitted. Please save these items for your celebration at home. We appreciate your cooperation.

There is a school calendar on the website that you will find very helpful. You can customize the view of your calendar to show just elementary events, if you prefer.

Character Education

Character Education is woven throughout all that we do in the elementary school. The traits we focus on include: respect, caring, self-control, responsibility, and leadership. We have a read aloud curriculum designed to help students develop empathy, kindness, and an appreciation for diversity.

Child Protective Services Visits

We are committed to cooperating with law enforcement authorities to keep students safe from harm and fulfill our legal obligation to report to CPS any reason to suspect a child has been abused or maltreated. The district will cooperate with local CPS employees who wish to conduct interviews of students on school property relating to allegations of suspected child abuse, maltreatment, or neglect.

DASA (Dignity For All Students Act)

New York State's Dignity for All Students Act (DASA) seeks to provide the State's public elementary and secondary school students with a safe and supportive environment free from discrimination, intimidation, taunting, harassment, and bullying on school property, a school bus and/or at a school function.

The DASA Incident Report Form can be found on the parent section of the website. The purpose of the form is to inform the district of an incident of discrimination or harassment (which includes bullying) so that we can properly investigate. Dismissal

Parent Pick Up

At dismissal time, students may be signed out in the cafeteria, after buses have departed. Please make sure you have identification with you. While our regular staff may recognize you without ID, we sometimes have a substitute in place. We will always ask for identification if we are unsure and we appreciate your understanding in this matter.

Taking Bus Home

Teachers will walk students out to their buses. If you need to pick up a student up at dismissal or any other time, please make sure you have identification with you.

Bus Passes

Occasionally, parents ask for their child to receive a bus pass to ride another bus, for the purpose of child care. Please make any requests for changes in transportation, before 1:00 PM, in writing, to Mrs. Lussier, our elementary school secretary. The best way to do this is to send a note into school with your child. Please call 639-5594 if you need clarification regarding this policy.

Walking Home

Only students in fourth grade and above will be allowed to walk home from school and they must have a signed permission slip on file in the office. Students walking home will be escorted to the parent turn around exit by an adult. Once they exit the door, they will no longer be under the supervision of school personnel. The school reserves the right to revoke the walking privilege from any student not behaving responsibly.

Signing Out Siblings

Only students in fourth grade and above will be allowed to sign their siblings out in the cafeteria and escort them to the parent turn around area. We must have a written note from a parent before allowing this to happen.

Biking Home

NYS Law requires children under the age of 14 to wear a safety helmet when biking. Therefore, students may be asked to walk home if they are riding a bicycle on school property, without a helmet. If you need to obtain a low cost bike helmet for your child, please call Washington County Public Health at 746-2400.

Dress Code

Parental guidance is necessary to help children make appropriate choices about their school attire. Students are expected to wear clothing that is appropriate for our school environment. Students may not wear items that: are offensive, express insults of any nature, promote the use of drugs, alcohol, violence, or contain objectionable language. Please avoid clothing that is too revealing and make sure students wear safe footwear. If a student is dressed inappropriately, he/she may be asked to change into extra clothing available in the nurse's office.

Early Arrival

Students may be dropped off at 7:45 AM to wait with supervision, until school begins at 8:00. Please use the parent turn around.

Family Outreach Center

We are fortunate to have a Family Outreach Center, that provides support to parents. The FOC offers a Weekend Backpack Program which provides a backpack full of food every Friday to students whose families could use additional assistance. This program is funded through donations. Meals From Home

If you send in a breakfast or lunch from home for your child, please focus on healthy, nutritious foods, as much as possible. We certainly do understand parents make their own choices about what to serve their children and that some children may eat a limited variety of foods.

Students are not allowed to drink soda during the school day. They are also not allowed to have any takeout (Dunkin' Donuts, McDonalds, Cumberland Farms) foods or beverages after the 8:00 AM bell sounds for the day. We appreciate your cooperation.

Report Cards

Elementary report cards are issued three times per year. Please refer to the school calendar on the webpage.

School Food Service

We offer breakfast and lunch on all full school days. Current prices are posted on the website, and so are monthly [menus](#). You can use [MySchoolBucks](#) to conveniently prepay for meals from your smartphone or a computer.

Snacks

Many elementary classes make time for a daily snack, to provide nutrition and energy. Please ensure that any snacks sent in from home are healthy. We do offer a daily snack at school that is free to all students.

Social Emotional Learning

In grades K-5, we utilize *Second Step SEL*, a universal, classroom-based, social-emotional learning curriculum for our students in kindergarten - grade 5, that nurtures children's social-emotional competence and foundational learning skills. The program builds a foundation for a positive, inclusive culture through developing social-emotional competencies, which include perspective-taking, empathy, processing emotions, understanding and resolving conflicts, and building positive relationships.

Technology

Elementary students are **not** allowed to have personal devices (cell phones, smart watches, portable game systems, ipads, etc.) in school. If a child has a cell phone or smart watch for use after school, he/she is expected to keep it in his/her backpack and have it turned off during the school day.

Transportation

Safety is our top priority! Therefore, we expect excellent behavior on school buses. Students must stay in their seats, and cooperate with the driver. All buses are equipped with video cameras to observe student behavior.

Students may receive a written bus conduct report, if their behavior is unacceptable. This may result in a corrective action such as: discussion with the principal, phone call to parent, detention, suspension from transportation, or other appropriate response. Administrators will use their professional discretion

Unfortunately, FACSD does not provide transportation for students living in the village and/or for students attending the pre-kindergarten program.

After School Transportation

There is after school bus transportation available on Monday, Tuesday, and Thursday. These bus runs are different from the regular after school routes. Please check with Mr. Larrow in the transportation department, regarding the details such as the bus number and drop off location. When elementary students stay after school for a club or other activity, a parent must write a note giving permission and communicating whether the child will be picked up or ride the bus home.

Visiting the School

We ask that you schedule an appointment ahead of time, whenever possible. All visitors must report to the elementary office upon arrival, and sign in. This helps us keep a safe environment for our students. If you need to pick up a student up at any time, please make sure you have identification with you. While our regular staff may recognize you without ID, we sometimes have a substitute in place.
